Information for item 6 on the agenda of the OGMS of 25/26 April 2024 about the Remuneration Report for 2023

**ELECTROMAGNETICA S.A.** has prepared the Remuneration Report in accordance with the provisions of Article 106 in conjunction with Article 107 of Law no. 24/2017 *on issuers of financial instruments and market operations*.

The Board of Directors presents the following information to the Ordinary General Meeting of Shareholders of 25/26.04.2024, regarding the fixed and variable benefits related to the members of the Board of Directors (BoD), the members of the Audit and Risk Committee and the CEO for the year 2023.

## Electromagnetica S.A.

In 2023, no bonuses/performance bonuses were granted to CEOs or Audit and Risk Committee members. The members of the Board of Directors received an additional compensation, considered variable, related to the Company's performance in 2022; the amount of the compensation granted at gross level for each member of the Board of Directors varies between 0.022% and 0.052% of the annual salary pool of Electromagnetica S.A., proportionate to the period they served as a member of the Board of Directors in 2022 for the Company.

The gross fixed income of Directors and Audit and Risk Committee members granted in 2023 by the Company varied between 0.082% and 0.305% of the annual salary fund of Electromagnetica S.A., largely depending on the period they have been active as Directors / Audit and Risk Committee members.

The gross fixed salary income for CEOs ranged from 1.124% to 1.999% of Electromagnetica S.A.'s annual salary pool, and is shown below. As an exception, a number of three CEOs had a lower gross fixed remuneration, generated by the shorter period of time they served as CEOs of Electromagnetica S.A. in 2023.
